We are in August 2016 and the people of Great Britain has just left the European Union. This is why we open our Bibles and share now about Brexit which is the exit of Great Britain from the European Union, about the Euro and about this fanciful enterprise named European Union.

A usual satanic trick of false temples's pastors and priests from this Romanian Babylon the great is to hide from the Born Again Christians across the world, the fact that GOD's WORD written in the Bible governs the invisible and the visible including politics and economy of the whole earth. And thus put under anaesthetic, the Born Again Christians end up forgetting that the Book of Daniel in Chapter 2 verse 44 states forever that GOD sets up on earth a Kingdom which is the Church and uses this Kingdom to break in pieces and consume all the worldwide satanic kingdoms across the earth in order to completely recover back the government of the world.

Nebucadonozor and Babylon tried hard to bring together the different peoples of the earth into a single global empire which according to their foolish dreams would be an eternal global empire.

What was the final outcome of all this enterprise? Failure, collapse and complete dismantling. That's what happened to the golden head that is to say the best of all pagan worldwide global empires that ever existed on earth.

As from the year 538 before the Lord JESUS CHRIST, the Medo-Persian empire replaced Babylon and returned to the same mad ambition: bringing together the different peoples of the world into a single global empire. This second attempt lasted only two centuries and the Medo-Persian empire collapsed.

bringing together the different peoples of the earth into a single global empire.

Final outcome of this enterprise? Failure and complete collapse.

In the year 168 before the LORD JESUS CHRIST, the Roman empire strove upon the great sea that is to say it suddenly burst into the world scene and fought for more than three centuries to achieve what the three previous global empires failed: bringing together the different peoples of the earth in one worldwide global empire.

What was the final outcome ? Failure and complete collapse of the Roman Empire in AD 478.

Since the collapse of the Tower of Babel, the elites of darkness have been vainly struggling to again gather the nations of the earth in a single global empire ruled by the antichrist of Satan. It is a madness doomed in advance to failure because since Babel, GOD has confounded the language of all the earth meaning that HE has made different from each other the spirits inhabiting the various peoples of the earth. Two individuals from two different peoples can get married if they want but the peoples are not individuals and cannot marry because each people has its own specific spirit and the most frightening is that a people which loses its spirit becomes a slave of the others. diverge and so it becomes impossible to consider a wedding or a merger between peoples into a single worldwide global empire. It is a curse from GOD, harvested by rebellious and animal mankind at the Tower of Babel.

An behold the Europeanists perfectly led by the antichrist spirit, unaware of the fundamental THRUTH that it was the Apostle Paul who laid the foundations of the present West and East (ah yes the East too) and who have put back again on the table the old and cursed dream of the Babel's tower: bringing together different European peoples under a single empire and under a single currency in a first step and in a second step, bringing all the peoples of the earth in a unique global empire with one currency and one antichrist ruler empowered by Lucifer who is Satan.

Is it not complete madness that Satan inculcates Europeanists elites? Does history not sufficiently teach how ends this kind of madness?

The foolish current European Union and its Euro are an antichrist rebellion of the Soviet type. A Supreme Soviet named "European Commission" has been established with an ultimate objective hidden in darkness; defy what GOD has written in the Book of Daniel.

This madness has just generated a monstrous situation; for the first time in world economic history an entire country has been turned into a gigantic bubble ready to collapse.

Here is the complete movie of the magic trick just played by the Europeanists.

Phenomenal amounts of Euros of poor quality has fled other European countries to seek refuge in Germany in order to benefit from a qualitative ennoblement. You will surely say it is good for the German economy but do not rush things when it

comes to drawing conclusions because economy does not tolerate magic and follows the principle of balance. When the holder of ten million poor Portuguese Euros transfers this amount of poor money at a commercial bank in Germany, he just exchange a vulgar Toyota Lexus or a vulgar Renault Talisman against a Mercedes car that can be used by two generations in a family. You guess it already that you must have someone pay for this exchange of vehicle just made by the Portuguese because the significant improvement in quality must be financed by somebody. And this is where you begin to understand the collapse of Germany ahead.

Since these phenomenal amounts of Euros of poor quality barged in Germany without going through the arbitration of a foreign exchange market (the neoliberals who dream of a new world order of darkness hate the markets they pretend to praise) the Bundesbank now finds itself hugely creditor of other European central banks that are insolvent. Currently the Europeanists magic trick translates into a huge rotten debt of nearly one thousand billion Euros (would you believe!) that the Bundesbank claims from other European insolvent central banks. Yes the official figure discreetly published by Bundesbank is 700 billion Euros but we must add an important component that Bundesbank set aside in order to mitigate the magnitude of the coming disaster; the huge amounts of low-quality Euro banknotes printed by insolvent central banks from southern Europe and which rational citizens have quickly rushed to deposit at the counters of banks in Germany or have quickly rushed to circulate within the German economy in an attempt to quickly convert every euro of poor quality printed by an insolvent central bank into a true Euro that is to say, into a potential Deutsch Mark. Yes if you have a poor Euro which is a claim against an insolvent central bank and you find a way to convert it into a claim against a solvent central bank, you will not hesitate and that is what many Europeans have done.

When comes the closing of accounts, who will pay for this rotten debt of nearly a thousand billion Euros that Bundesbank (Buba you can call if you have any affection for her) holds on foreign insolvent central banks? The answer is that you guess. Say it simply. Since Bundesbank belongs to the German State, it is ultimately the German citizen who will pay this bill. Taxes increasing, massive unemployment, loss of social benefits, cuts in State spending, that's the next cocktail which awaits the Bavarian who quietly reads the story of Martin Luther to his wife and has never asked for any "European dream" from the elites of darkness who have engaged Germany in a rebellious project against GOD named Euro Zone. When a so called pastor's daughter's objective is to do the opposite of what is written in the Bible the result is catastrophic as you can see.

So here we are with a whole country turned into a bubble ready to collapse. Back to the era of the Reichsmark.

European peoples will never form a European people like the African peoples will never form an African people. Equally, you have many Asian peoples but you cannot find the Asian people. At thy quarter's café, thou will always have in front of thee, various European peoples, various African peoples, various Asian peoples and the manager of thy quarter's café must absolutely get used to the multitude of accents, to the multitude of languages and to the multitude of currencies if he want to efficiently sell his Bavarian beer.

After Brexit the Deutschxit which means Germany getting out of the Euro Zone and out of the European Union, is of utmost urgency to limit the amount of the invoice of madness that will pay the German citizen. The elites of darkness in Germany believe they have found another solution: push the sale and plunder of the assets of other European States which cannot repay their debts. This is a stopgap solution that will

strengthen the hatred between European peoples who only wanted to live in peace with each its own currency, its own central bank and its own nationality. The future of the European Union and the Euro has already been written by history in a movie that everyone knows: the collapse of the USSR ! Watch this movie and see how many peoples which were once thought to be brothers were eager to quickly leave the USSR for each to rebuild its own country and its own currency. Where is Tito's Yugoslavia?

The antichrist spirit of the global Ubuntu is actually shared worldwide by reactionary elites deprived of lessons from the history. Thus, at the dawn of African countries independence, Nkwame Nkrumah had this hallucination of a Federal African State! Just think about it five minutes. Crowds of different peoples who have not yet learned to come together to manage a joint airline company (Air Afrique) assemble themselves suddenly in a single Federal Republic ! This kind of craziness is common in Africa, where because they lack authentic spirit within themselves, African Heads of States display all through the years a permanent show of foolishness and delusion.

You would think maybe the hallucination of Nkwame Nkrumah is no longer in fashion today in Africa; quickly open your eyes and don't be so sure. When you open the foundation Charter of the African Union that is to say the founding birth certificate of the African Union, you will discover therein many more disasters and we are going to share one of these disasters because it is a critical one. To kick off let us remember that the original foundation document of the African Union is written in Arabic, French, English and Portuguese. It is obviously inconceivable to write the original of African Union's birth certificate in Amharic, Swahili, Hausa, Fulani, Lingala, Zulu, Xhosa or Igbo but we can accept this as normal as you already know that peoples without spirit pays no attention to their native languages and therefore cannot conceptualize the world. Do not request too much effort from such peoples by insisting that they should write their birth certificate in their

own native languages. Let us rather move to the critical disaster: in its Article 19 the founding charter of the African Union provides to the great shame of the African deprived of authentic spirit an African Central Bank. Watch the peoples devoid of spirit which are wandering at the tail of the world and are feeding themselves upon hallucinations. Providing an African Central Bank in the African Union's foundation Charter simply means that the African Union's objective is to gather all the African countries under a unique currency managed by such African Central Bank. You already see the extent of the aberration because since fifty years, seasoned economists and seasoned bankers know that if you want to gather several countries under a single currency, this can only succeed if these countries grouped under the single currency meet the criteria of Optimum Currency Area (OCA) because if these criteria are not met properly, the whole Monetary Area under the single currency will just collapse and melt away like butter under the sun when facing the first serious asymmetric shock. Let us quickly share few details about the criteria for an Optimum Currency Area. In political economics, you gather several countries under a single currency managed by a single Central Bank if the following optimality criteria are met:

First criterion; total geographical mobility of production factors that are labor and capital. Men and capital should move freely within the Area made of all the countries which are gathered under the single currency.

Second criterion; common fiscal policy authorizing budgetary transfers within the Currency Area.

Third criterion; strong business integration that is to say, intense and free movement of goods and services within the Area.

These three conditions must be met to make the Currency Area being optimal that is to say, being able to absorb asymmetric shocks. If not optimal, the Area will fall when hit by the first serious asymmetric shock. And if you politically decide to keep alive a non optimal Currency Area which is facing asymmetric shocks, the price of thy political derailment will be dearly paid

by a well known factor of production which is labor, that is to say, the inhabitants of the Non Optimal Currency Area will pay the price with unemployment, poverty, social strife, disorders of all kinds in the social engineering, backwardness.

Political economics does not tolerate magic and each magic trick is cash paid by someone.

Just to give an idea let us consider Tanzania which has its own currency the Tanzania Shilling and its own Central Bank. Tanzania is an Optimum Currency Area because the three optimality criteria are met in Tanzania. Tanzanian population and capital move freely within Tanzania. The criterion N°1 is respected. Tax revenues from the sea port of Dar es Salaam are partially assigned to the achievement of investments in poor regions of Tanzania. The second criterion is respected. The goods and services move freely within Tanzania. The third criterion is respected.

Now let us test two asymmetric shocks among which one negative asymmetric shock and one positive asymmetric shock. A severe drought sweeps a region of Tanzania. The impoverished people inhabiting the region hit by the asymmetric shock circulate and establish themselves in other regions more purveyors of employment and income as the criterion No. 1 is respected. The State operates budgetary transfers in favor of the region hit by drought since the criterion No. 2 is respected. The private sector flows unimpeded large quantities of goods and services to the affected region to ensure the consumption of citizens dwelling in the disaster area. The respect of the three optimality criteria relaxes political, financial and economic tensions and protects the overall cohesion of Tanzania as an Optimal Tanzanian Shilling Area. Now let us consider what happens if a specific region of Tanzania suddenly reveals to be a gigantic reservoir of gold, diamond, oil and gas. It is still an asymmetric shock which this time is positive but will also blow up the Currency Area if such an Area is not optimal. Populations and private investors from other parts of

Tanzania will freely migrate to the Eldorado region and earn incomes and fortunes. Criterion No. 1 is respected. The Tanzanian government will reap significant tax revenues in the Eldorado region and then invest in other parts of Tanzania. Criterion No. 2 is respected. Your Tanzanian uncle who is a trader will freely buy goods and agricultural products, transport them to the Eldorado region, sell them there and become rich. Criterion No. 3 is respected. Because of the respect of the three optimality criteria the Tanzanian Shilling Area will not undergo political, financial and economic tensions leading to its collapse. From these two examples, you understand that a Currency is intimately linked to a given nation and you cannot built up an Optimal Currency Area just by pushing many countries under a single Currency managed by a single Central Bank. I you still have some doubt about this, please put Mozambique and Senegal under a single Currency managed by a single Central Bank and then apply an asymmetric shock that is for example gigantic reserves of mines, oil and gas discovered in Mozambique only. Will you just imagine the government of Mozambique operating important budget transfers in favor of Senegal? Will you imagine one million Senegalese setting in the new Eldorado country which is Mozambique in order to work and get rich there? Of course as you know it is very easy for Senegalese traders to transport their goods to Mozambique, sell them there and get rich. Is it not clear now that we have here in Africa foolish Head of states deprived of spirit who write in the African Union birth certificate things which they just copied from their Western illuminatis masters without understanding what they are copying? You have now understood that a negative asymmetric shock that is to say, a great misfortune affecting a specific region of the Currency Area without affecting the other regions and a positive asymmetric shock that is to say a great fortune affecting a specific region of the Currency Area without affecting other regions can both blow away through unbearable political, financial and economic tensions the Currency Area if such Currency Area is not optimal.

And behold our wacky African Heads of States who return to Nkwame Nkrumah's hallucinations and are now dreaming about gathering 54 African countries under a single African Central Bank that is to say under a single Currency Area. Measure by thyself the depth of their hallucination. Do Africans circulate freely between African countries? Are there budgetary transfers between African countries? As you know the movement of goods and services between African countries is quite easy.

In addition to the optimality constraint, there are two equations which must be properly solved if you want to build a viable Currency Area. The first of these two equations is the external exchange rate of the common currency managed by the common Central Bank. If you want to lock up 54 African countries in an African Central Bank, then the intra African trade must overwhelmingly outperform the trade between Africa and the rest of the world. Specifically the value of each African country imports from other African countries must represent at least 80% of total imports of the considered African country. Then the value of each African country exports to other African countries must represent at least 80% of total exports of the considered African country. Now you know that the intra-African trade is meaningless and our African countries which of course do not have at all the same international trade structure, trade mainly with countries located outside the continent. As a result, the exchange rate of a common currency will necessarily be too expensive for some countries and destroy their international competitiveness while it will be cheaper for other countries. Impossible in such a situation to find an external exchange rate that suits every African country and such schizophrenia is simply not manageable. The second equation impossible to solve is that of the interest rates set for all 54 countries of the Currency Area by the single common Central Bank. Since the economic structures of the African countries are different, the interest rates decided by the single common Central Bank will be systematically too high for many countries, thus bringing

down their economies while at the same time these interest rates set by the common Central Bank will be too low for other countries eager to fight for example against inflation. This second type of schizophrenia is also unmanageable. All seasoned economists and seasoned bankers are familiar with both insolvable equations of external exchange rate and interest rates which we have just shared.

And what happens if despite the non-optimality of the Currency Area and despite the impossibility of solution for both equations of exchange rate and interest rates, you stubbornly maintain alive through political dictatorship the Common Currency Area? The answer is that someone has to pay the price for this magic because political economics does not tolerate magic tricks and the name of the one who pays the highest price is well known: the population of the Currency Area will pay a high price in terms of unemployment, disorders in the social engineering, poverty and backwardness. This means using a common Currency as a weapon to repress peoples, weaken them and bring them down so low that they will subscribe without resistance to the hidden satanic agenda of global empire dreamt of by the elites from darkness. It is this common Currency used as a warfare weapon against peoples that European peoples in the Euro Area are increasingly opposing and now the Europeanists from this Supreme Soviet named European commission have but only one solution remaining for their quest of a Satanist global empire: prohibit any possibility of further referendums on "stay in the Euro" or "leave the Euro".

The lack of optimality, the schizophrenia of a single external exchange rate for many countries with different international trade structures, the schizophrenia of a single interest rate for many countries with different economic structures are the three reasons why the Euro Area has failed and the Europeanists elites knew these three reasons very well from the very inception of the Euro but at that time they bet on the hazards of history because Satan does not have enough time

for his vain project of world government. And yet, there is no hazard in history because all the history of mankind is written in the Bible by the LORD JESUS CHRIST.

This is the only positive outcome of this mad enterprise of the European Union and the Euro. This mad business of European Union and Euro construction has brought to light a fundamental fact that Africans in the CFA Area should have understood and act accordingly. What is it about? It's simple. The European Union and the Euro have brought to light the fact that the political and economic elites who govern France have been and are completely driven by a racial vision of the world and fully assume their racial vision of the world when they are in the field of action. Each year, France contributes in net, an amount of nearly eight billion Euros (yes you have well understood nearly 5 247 billion FCFA per year) in order to finance the economic upgrading (which is keeping itself awaited) of many Europeans countries which have never spoken a word of French, know little about France, hardly send their citizens to study in France ... etc.

So in a year, France gives to other less developed European countries and this via European Union, an amount that far exceeds anything the alleged French cooperation has brought in sixty years to African countries of the CFA Area that speak French, militate fervently in the French Speaking world Organization for the worldwide influence of France, resort preferably to French citizens when they need technical assistance, have a clear preference for French companies when it comes to handing over portions of the national economy to foreign companies through the well know so called concessions, send thousands of students to study in France. What justifies this? Here you are looking up to the ceiling of thy domicile and trying hard to run away from the TRUTH shouted by the facts. But you cannot prevent the facts from shouting the TRUTH at your ears! The only thing that France has in common with the least developed European countries to

which France gives eight billion Euros each year that is to say 5247 billion FCFA each year and that France has not in common with African countries of the CFA zone is the color of the skin. This color of the skin is Black in African countries of CFA Area and it is white both in France and in other less advanced European countries of the Euro Area. That is the racial vision of the world revealed by the facts and shouted aloud by the facts. You yourselves can now see it clearly that the varnish of the humanist discourse from this Masonic 18th century and the varnish of the discourse from the so called “French Revolution” are nil and void because the facts speak enough and the facts are enough for those who understand the facts. Bulgarian, Cypriot, Polish, Czech, Slovenian, Slovak, Lithuanian, Latvian to whom France gives annually 5,247 billion FCFA to support their economic upgrading do not speak the French language as the African countries in the CFA Area do, they do not militate fervently in the French Speaking world Organization for the worldwide influence of France as do the African countries of the CFA Area, they do not massively send their citizens to study in France as do African countries of the CFA Area, they do not preferably resort to French for technical assistance as the African countries of the CFA Area do, they do not proclaim themselves “best students of France” as do the African Heads of States of the CFA Area.

Yet a paramount hidden interest urges the political and economical elites who govern France to give in a single year to the less advanced countries of the European Union, an amount that exceeds by far all that the so called French cooperation gave in sixty years to all the African countries of the CFA Area. But what is this paramount interest? Look at the color of the skin and may be also at the shape of the nose and you will quickly understand that this paramount interest is the dangerous racial vision of the world. The color of the skin is all that Slovakia, Slovenia, Latvia, Poland, Lithuania, Cyprus and others have in common with France and which France do not have in common with the African countries of the CFA Area. This paramount interest which is the color of the skin

outperforms by far the sharing of the same official language which is French, the common militancy within the French Speaking World Organization, the deposit of foreign exchange reserves with the French Treasury, the crowd of French citizens working as technical assistants in our various institutions, the exceptional position automatically allotted to French companies like Bolloré all through African countries of CFA Area ... etc. Shall the wacky Heads of State of Africa take note of this racial vision of the world and of this racial conceptualization of the world and shall these barmy foolish African Heads of States measure the dangerousness of such racial vision of the world? No and no because the wacky tropical Head of State is the product of his Masonic grand master of Gallic lodge who initiated him to the 33rd degree of the freemasonry of darkness.

As our crazy African Heads of States have no spirit within themselves, they cannot quickly set up an action plan spanning over a century in order to revive our African languages and implement the death of the French speaking World and the death of the FCFA within a century via systematic recovering of our own language and systematic recovering of our own spiritual, intellectual, political and economical world conceptualization. These fools who understand neither the facts of history nor the lessons springing from these facts, will put the African peoples at the mercy of Masonic French elites who consider the world only through a perfectly racial vision despite universalist official discourses, speeches and declarations. This how is brewing the end of African peoples who draw no conclusion from political and economical facts of the world, not to mention higher facts which are spiritual. Here we must do justice to the TRUTH, by recalling the fact that the French people itself is a victim of French political and economic elites that bear and promote a deadly racial vision of the world. The French people shouted a big "no" and rejected in a referendum held in 2005 this mad construction of European Union and Euro but the political and economic elites governing France disregarded the "no" shouted by the French

people, which since then has been forcefully enrolled in a racial vision of the world which it has rejected through the referendum. So the racial vision of the world is not from the French people but from the elite of darkness who vainly aspire to challenge GOD's WORD written in the Book of Daniel.

And what is the reaction of our tropical Heads of States to all this? They do nothing and cannot do anything because only authentic Men of GOD are able to lead the African continent to its Destiny assigned by GOD. The initiated tropical freemason and his rosicrucian accomplice were and will forever be slaves to their so called Western grand masters from the lodges who initiated them to the 33rd degree in the lodge of darkness. This is how is sealed the ultimate death of Africa of darkness.

the wacky tropical dictator deprived of spirit within himself has no spiritual weapon to counter this dangerous racial vision of the world leading French leaders, revive his own languages and implement within a century his own vision of the world and his own currencies.

He can only declare himself to be the best student of his grand master of the Masonic Gallic lodges. And when he happens to dream at night it is only about the hallucination of a Federal African State even though he knows not how to deploy the cooperation between the African peoples. Look and see our wacky African Head of State of the CFA Area instruct (they love to give instructions) the Governor of the Province, the Prefect and the Chief of the village to quickly organize a party meeting during which the villagers will dance, will roll their naked chests, will sway their hips at the rhythm of drums; all this in order to thank the French cooperation representative which has financed a small well in the village. Now that we have shared the only positive outcome of the European Union and the Euro namely the revelation to light of the authentic racial vision of the world leading the political and economic elites who govern France, which racial vision of the world was however rejected by the French people in a referendum carried in 2005, it is worth recalling to the sorcerer's apprentices of the new world order of darkness, some axiomatic of systems science .
